In continuation of this office letter No. Acad/7240 dated 21/02/2019 on the above-noted subject, I am directed to inform you that the Academic Council vide its meeting dated 04/5/2019 has resolved to revise the resolution of the Academic Council's meeting dated 31/01/2019 on the above-noted subject as follows:-

Agenda 3 of the meeting held on 3/01/2019-In the resolution at serial No.(ii)a, 30 in pace of 3 be substituted.

The other contents of this office letter No. Acad/7240 dated 21/02/2019 will be remained unchanged. Now, the following will be effective:-

**“ The End Semester Examination (ESE) for AECC-I is of 50 marks only. However, there is no separate provision mentioned in the Regulations. Hence,**

- (i) **The ESE for AECC-I will be of three hour duration as is mentioned in the Regulations of CBCS,**
- (ii) **The question pattern will be**
  - a. **Multiple Choice questions-30 each of one mark, i.e., 30 marks.**
  - b. **One long Essay to be written in minimum of 1000 words from a set of options of 5 topics- of 20 marks.**
