Sub: - Regarding provisional admission in Ph.D. course work.

Sir/Madam

In continuation of this office letter no. Acad/-7594 dated 18.04.2019 and in pursuance of the decision taken at the meeting of the Deans of the Faculties and the Heads of the Departments held on 18.04.2019, I am directed to request you to take following necessary actions:

1. The Heads of the Departments of the respective departments will send immediately detail syllabus of paper II containing research methods specific to concerned subject as per the provisions contained in clause 7.3 of the Uniform Ordinance and Regulations governing award of Ph.D. Degree by the Universities of Bihar.
2. The Deans of the concerned Faculties in consultation with the respective Heads of the Departments will send a syllabus of Paper I containing research methodology which may include quantitative methods and computer applications: reviewing of published research in the relevant field and other techniques / methods, specific for the broad subject area. Those who have sent, need not to send again.
3. The timing of the Course Work of PMIR and Commerce subject will be from 01 p.m. to 3 p.m. whereas other departments will conduct Course Work classes from 3 p.m. to 5 p.m.
4. Fifteen days time from the date of admission will be given on submission of undertaking by the applicants for submission of Department Leaving

Certificate / No Objection Certificate from the employer in case of employment failing which the applicant will forfeit the right to take admission.

5. The Head of the Department will recommend the names in second list for admission if the seats remain vacant.

6. It is further requested that

(a) Deans of the Faculties will arrange the classes of Paper I of the respective faculties in the first three months and thereafter the respective Heads of the Department will arrange classes of Paper II in the last three months.

(b) Admission process of the remaining vacant seats shall be over latest by May 4, 2019.

(c) Wherever the admission process is complete, the Department concerned will send complete list of all the provisionally admitted students in the following format so that finally a formal approval letter containing details of the students could be issued for their records.

(d) The data of the provisionally admitted students in the prescribed format in excel sheet may also be forwarded to the email i.d- Inchargepucc@patnauniversity.ac.in with a copy to k_mukesh@live.com. for publication on P.U. Website.
